On May 2, 2025, Charles Talbert ("Requester") submitted an appeal with this Office pursuant to the Right-to-Know Law ("RTKL"), 65 P.S. § 67.101 *et seq.* A copy of Requester's appeal is attached hereto and labeled "Requester's Appeal."

Upon review of the appeal, it is determined that the appeal must be dismissed because the appeal is insufficient. The appeal does not meet the requirements of 65 P.S. § 67.1101(a)(1), as it does not include copies of the Request, or the Senate Open Records Officer's response thereto, if any. In fact, the appeal does not specify the agency to which the request was directed. Furthermore, the appeal does not state the grounds upon which Requester asserts that the records sought are legislative records, nor does it address any grounds stated by the agency for denying the request.
